Building Fitness Center Rules and Regulations

- Once you have completed the appropriate forms for access to the fitness center your assigned access device will be programmed to allow access into the Building Fitness Center (fitness center) and the appropriate shower/changing area.
- You must utilize your device only for access; the use of another individual's device can result in termination of both people's access & use of the fitness center. Please tap your device at the access device reader every time you enter the fitness center.
- All users should exercise good judgment when selecting proper exercise attire when using the fitness center. All users will be required to wear shirts and athletic shoes at all times (shoes excepted during floor exercises, yoga or aerobics).
- There is a 20-minute time limit on the cardiovascular machines when another user is waiting for this machine. All users are asked to be courteous when working out.
- Please wipe all cardiovascular and weight equipment as you finish utilizing them. Additionally, please clean up after yourself in the workout areas as well as the shower/changing areas.
- Do not drop weights as this creates noise that carries to other floors and lease spaces.
- Televisions are provided for your use at your discretion. Please avoid loud or offensive programs while other users are present. You may bring in your own Blue-ray or DVD to use in the aerobic/floor exercise area. Please turn off the television when you are finished viewing it, unless others are still viewing.
- Use of the fitness center is solely for my individual use, not family or friends. You must be a customer of 816 Congress to use the facility; NO external trainers or instructors are permitted. At no time are children allowed to be in the fitness center.
- Hours of operation are 24/7, exclusive of 8PM-10PM Monday through Friday for cleaning by the building's janitorial contractor and building Holidays. The fitness center may remain open at other times, or be closed during regular hours, solely at the discretion of building management.
- The fitness center does not utilize an operator to run the facility. You must provide your own toiletries. Towels are provided.
- There are separate Men's and Women's shower/changing areas and lockers are available for your use. Instructions for the locks are posted in the locker area. All items must be removed from the lockers when you finish utilizing the fitness center and absolutely nothing may be stored overnight. As these lockers are not reserved, they are on a first come, first served basis. Please be considerate of others.
- Items are not to be staged at the showers as you are working out, only placed there just prior to showering. It impedes the flow of people getting in & out in a timely manner.
